PREPARING FOR THE EVENTUALITY: HOW EMBRACING THE END COULD CURTAIL CORRUPTION, FOSTER EMPATHY AND ENHANCE THE VALUES OF HUMANITY

ne of the conversations I had two day's ago, was quite exciting, and I found myself eager to move forward with more details. This was a polish-American man soliciting advice on the configuration of his funeral plan, and his Legal Will.

Among the discussion I had with him, I found one conversation about his choice of obsequies by process of "CREMATION", particularly exciting, and I am looking forward to see you exploring the idea of post-life plans. There are many advantages to it, and more of great benefit to those one leaves behind, and to the happiness of one's soul personality.

After he assimilated my opinion on his legal Will's distribution of material wealth to his family members, charity organizations, religious center and research institutions, he came up with the fact that his body should be disposed by process of cremation. Then he asked me, "what do you think and how can that be enforced when I pass?"

"My response to him was, every Legal Will, being legal instruments, when made in accordance to law, are bound to be enforced by family members and administrators of estate".

WHY PEOPLE FEAR TO DISCUSS DEATH

In keeping with today's lecture, which is devoted to how one can render assistance to himself and others before death, we cannot but accept the fact, that for many people, the subject of "DEATH" and everything surrounding it is taboo, a subject to be avoided. Many people believe that the mere fact of discussing death brings about misfortune and could cause premature death. Obviously, such a belief is founded on ignorance, superstition, low-intelligence and lack of integrity --- a disparagement of an inevitable truth, as well as loss of thought with the fundamental laws of nature.

WHAT IS CREMATION AND ITS ADVANTAGES?

As I mentioned, I was particularly interested in discussing cremation with the fellow because I am a believer in that concept --- the fact that incineration, a situation where the body of the deceased person is burned, as opposed to burial --- a slow alchemical process which consist of placing the deceased in the Earth, is a rapid alchemical process that does not only helps in cleansing the ecological environment from the diseases and impurities of the dead body, but also is for the good of a soul personality, in making transition process rapid and more tranquil than burial.

• FUNDAMENTAL FACTOR THAT MAKES PEOPLE PREFER BURIAL TO CREMATION WHILE CREMATION IS ADVANTAGEOUS

One of the factors that make people prefer burial to cremation is religious dogma --- such as the belief that one day a trumpet will be blown, and all the dead people will rise from the grave and fly up to the sky --- heaven and live

again in body. This belief is completely incompatible with scientific reality and natural law system. A dead body cannot be reconstituted after its disintegration, because it is only the soul that is an eternal creative energy. As we all know, energy is indestructible. it can only transformed or converted but can never be annihilated.

In studying the chamber of death, the soul disintegrates from the body gradually and after three days and a half day, it commences its journey of ascension or degeneration to the spiritual sphere corresponding to its degree of soul evolution. The body after turning to dust, cannot reconstitute with the soul to fly up to the sky someday. It makes no scientific sense as people believe that human body that has degenerated in the grave for millions of years, with some graves carrying millions of agelong body dust of several decades, will reconstitute a body.

CONCLUSION

Back to the issue under discourse, we must now consider a matter before closing this lecture. That is the significant of pre-death legal instrument.

The first advantage of pre-death legal instrument for one's post death incident, is that, it curtails or eliminates potential family conflict and dispute, and causes people to adhere to instruction on how one's personal legacy and body will be handled after his death. A kind of something you would have love to do for yourself if you were alive --- but as you are helpless, people do as you would wish.

Second, it helps in preserving your legacy.

Some of the lessons to learn from the fellow whom I opened this lecture with, are as follows;

In his Legal Will, 30% of his wealth goes to humanitarian charity. 30% to

educational and health research while 40% is declared to be shared among his

children, wife and siblings. These are what he is doings while alive. So the legal

instrument will then preserve the legacy without obstruction when he passes.

Another lesson is, he is just 58 in age and when I asked, "do you have any

terminal disease? why so early?" The answer was "Nope. I am well. But I think I

am even late. Last year I escaped a plane crash. What if that had happened?". He

hastened to add: "If we people of the world are conscious of, and plan for

inevitability of death, unnecessary competition, unwarranted greed and

accumulation of money to have fat bank accounts, and incessant actuation of

harm on other people will be minimized, or if possible, cease to happen, and the

world will be a harmonious place".

This is the fact. another advantage is that it makes us understand and value the

principles of humanity. It enhances our spirituality and make us to be humble

and more decent in character because we know that everything is ephemeral,

so why all the dirty fight to become richer and more powerful than others which

brings hate, war and lack of empathy.

Whatsoever situation, you will note that peace in mind and soul should be the

greatest desire of a soul personality.
